



# TALENT *Scholarships*

Escuela Universitaria de Artes TAI is a private institution financed by its teaching activity, Public Institutions are responsible for the granting of bigger scholarships. The corresponding forms, available at [www.taiarts.com](http://www.taiarts.com), must be submitted together with the requested documentation.

## GENERAL RULES OF APPLICATION

### 01 OBJECTIVE

Escuela Universitaria de Artes TAI opens a call for Talent Scholarships during the 2023-2024 academic year, their objective is to support the artistic training of all those students who demonstrate extraordinary talent and a high creative capacity and commitment to the project of the TAI Arts Community.

### 02 BENEFICIARIES

Talent Scholarships are awarded for one academic year. In order to renew the scholarship, the student must apply for the next edition, with the subsequent evaluation and recognition by the scholarship committee that he/she is worthy of the renewal.

→ All those endowed with TAI's Talent Scholarships will collaborate in internal and external events in which the university participates, as well as in cultural projects, artistic activities and clubs.

### 03 ENDOWMENT

From 10% to 50% (excluding reservation and administrative fees).

### 04 APPLICATION FORMALIZATION

Applications must be submitted using the application form available on the website. Any application that has not been submitted electronically through the application form hosted on the [taiarts.com](http://taiarts.com) website will not be considered.

Documentation to be submitted:

- \* Scholarship application form.
- \* Motivation and commitment report (minimum 2.000 characters).
- \* Curriculum vitae.
- \* Report of professional projection, future projects (minimum 2,000 characters).
- \* Letters of reference (minimum 3 letters of reference).
- \* Evidence of the best work done to date, both academic and professional (Portfolio).

If the documentation provided is incomplete or does not meet the requirements of this resolution, the application will be rejected.

## 05 RESOLUTION OF THE AIDS

The resolution of the scholarships, made by the scholarship committee, formed by academic advisors, area directors and professors, will be communicated to the applicant by e-mail.

The criteria used for the selection will be the following:

- \* Involvement / proactivity outside the classroom.
- \* Commitment to the career.
- \* The quality of the portfolio submitted.
- \* References from professors.
- \* Motivation letter / job projection.

The Talent Scholarships are not cumulative with other types of aid, bonuses or internal scholarships.

In the case of being in the last year of studies, this aid will apply to the completion of other studies in the academic year 24-25.

## 06 MONITORING AND JUSTIFICATION

Escuela Universitaria de Artes TAI may request from the beneficiaries of the scholarships any additional information deemed necessary to justify their proper use of the scholarships. The beneficiaries of the scholarships will be subject to the follow-up actions carried out by Escuela TAI.

## 07 OBLIGATIONS AND BREACHES

The student who benefits from this type of scholarship agrees to maintain satisfactory academic and attendance records for all program subjects and to be up to date with payments.

Total or partial breaches with the requirements and obligations established in these conditions and other applicable regulations, as well as those established in the corresponding endowment resolution, shall lead to the opening of a breach file, the resolution of which may result in the revocation of the aid granted, without the right to any claim whatsoever on the part of the student.
